## **CONSTRUCTION NOTICE**

**TO: BUSINESS PERSONS AND RESIDENTS**

**RE: FERMOR AVENUE BRIDGE OVER SEINE RIVER – BRIDGE REHABILITATION, PEDESTRIAN-CYCLIST UNDERPASS STRUCTURE AND ROADWORKS FROM ST. ANNE’S ROAD TO ARCHIBALD STREET.**

We wish to advise you that the above street renewal project is anticipated to begin in early May 2018 and weather permitting, be completed by the end of October 2019.

The work will include rehabilitating the existing bridge, reconstructing Fermor Avenue with a new surface, including safety, geometric and access improvements, pedestrian and cyclist facility pathways including a new pedestrian-cyclist underpass through Fermor Avenue.

The Project will be completed in two stages and includes the following work:

- Stage 1 (May through October 2018) – Construction of the south half of the Pedestrian-Cyclist Underpass, north half of the bridge, Fermor Avenue/St. Anne’s intersection, and the eastbound lanes of Fermor Avenue between St. Anne’s intersection and the Pedestrian-Cyclist Underpass; and,
- Stage 2 (April through October 2019) – Construction of the north half of the Pedestrian-Cyclist Underpass, south half of the bridge, and Fermor Avenue between St. Anne’s and Archibald Street.

One lane traffic westbound and one lane traffic eastbound Fermor Avenue will be maintained at all times during construction. During winter 2018/2019 Fermor Avenue will be re-opened as two lanes of traffic westbound and two lanes of traffic eastbound. Access to businesses and residential premises may be interrupted for short periods, but we will contact you in advance if that is required. Some turning movements may be prohibited for short periods. Those persons with accessibility needs are asked to contact the undersigned for additional information. Winnipeg Transit stops may be temporarily relocated to accommodate construction activities.

We will attempt to minimize the inconvenience and disruption as a result of this project.
