 - (i) Crate: Plywood, Spruce or Fir
 - a) 19mm ($\frac{3}{4}$ " Plywood)
 - (ii) **Spruce Board Veneer**
 - a) 1" x 6" **Spruce Board**. No. 2 Grade or better.
 - (iii) Paint/ Stain
 - a) **Exterior grade latex**
 - b) Specific RAL and Pantone color numbers shall be supplied by the Contract Administrator
 - c) Submit colour sample of paint for Contract Administrator's approval. Deliver samples prepaid to Contract Administrator's business address and Notify Contract Administrator in writing, at time of submission of deviations in samples from requirements of Contract Documents.
 - (iv) Rigid Insulation closed cell, expanded polystyrene 25mm (1") thick or approved equal **in accordance with B.7.**
