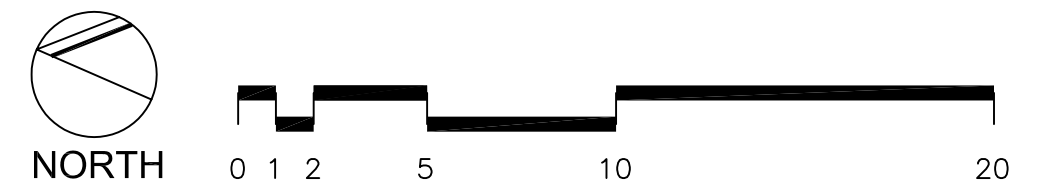


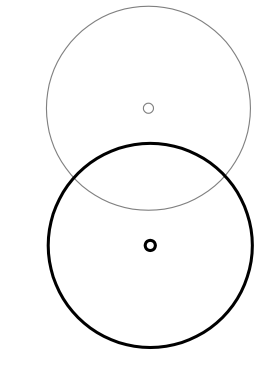
GENERAL NOTES

1. CONTRACTOR TO CONFIRM LOCATION OF ALL UTILITIES PRIOR TO CONSTRUCTION.
2. CONTRACTOR TO CONFIRM ALL DIMENSIONS AND REPORT ANY DISCREPANCIES TO CONTRACT ADMINISTRATOR PRIOR TO CONSTRUCTION.
3. LAYOUT TO BE APPROVED BY CONTRACT ADMINISTRATOR PRIOR TO ANY CONSTRUCTION, OR REMOVALS.
4. ALL DIMENSIONS ARE IN METRIC UNLESS OTHERWISE NOTED. DECIMAL NUMBERS INDICATE METERS. REFER ALSO TO WRITTEN SPECIFICATIONS.
5. CONTRACTOR TO REPAIR ALL ON AND OFF SITE SODDED AREAS, TREES, CONCRETE, ROAD PAVING AND CURBS ETC., DAMAGED DURING CONSTRUCTION TO CONTRACT ADMINISTRATOR'S SATISFACTION AND TO THE CITY OF WINNIPEG STANDARDS AT HIS OWN COST.
6. CONTRACTOR TO REPAIR ALL ON AND OFF SITE SODDED AREAS, TREES, CONCRETE, ROAD PAVING AND CURBS ETC., DAMAGED DURING CONSTRUCTION TO CONTRACT ADMINISTRATOR'S SATISFACTION AND TO THE CITY OF WINNIPEG STANDARDS AT HIS OWN COST.
7. CONSTRUCTION ACCESS TO BE LIMITED TO THE ROUTES SPECIFIED ON SITE BY CONTRACT ADMINISTRATOR
8. FILL ALL HOLES/DEPRESSIONS LEFT BY EXCAVATION AND REMOVALS OPERATIONS TO DESIGN SUBGRADE ELEVATIONS WITH MATERIAL SUITABLE TO SURFACE FINISH. REFER TO GRADING PLAN AND WRITTEN SPECIFICATIONS
9. DURING CONSTRUCTION, CONTRACTOR TO PROTECT TO CITY OF WINNIPEG STANDARDS ALL EXISTING TREES TO REMAIN
10. CONTRACTOR IS RESPONSIBLE FOR ALL REMOVALS AS REQUIRED TO CONSTRUCT ALL WORKS AS SHOWN ON PLANS AND DETAILS. ALL ITEMS TO BE REMOVED MUST BE DISPOSED OF LEGALLY OFF SITE.
11. ROCK PLACEMENT TO BE APPROVED ON SITE BY CONTRACT ADMINISTRATOR PRIOR TO INSTALLATION.
12. PLACE ROCK BENCHES AS DIRECTED ON SITE BY CONTRACT ADMINISTRATOR.
13. CONTRACTOR TO INSTALL WASTE RECEPTACLE TO CITY OF WINNIPEG SPECIFICATIONS
