



- THE ELECTRICAL SYSTEM SHALL COMPLY WITH THE REQUIREMENTS OF THE LATEST EDITION OF THE CANADIAN ELECTRICAL CODE (CEC) AND WITH ALL
- PROVINCIAL AND MUNICIPAL LAWS, RULES AND ORDINANCES.
- COMPLETE ELECTRICAL SYSTEM.
- EXAMINE ALL PLANS AND SPECIFICATIONS PERTAINING TO THIS CONTRACT, NOTIFY CONTRACT ADMINISTRATOR OF ERRORS OR OMISSIONS BEFORE SUBMITTING THE BID PRICE. FAILING SUCH NOTIFICATION, THE CONTRACTOR SHALL MEET ALL SUCH REQUIREMENTS WITHOUT EXTRA COST TO THE CITY OF WINNIPEG
- THE CONTRACTOR SHALL OBTAIN ALL NECESSARY PERMITS, PAY ALL NECESSARY FEES AND GIVE ALL NECESSARY NOTICES. ALL EQUIPMENT SUPPLIED UNDER THIS CONTRACT SHALL BE NEW AND SHALL BE CSA AND LOCALLY APPROVED.
- ALL WORK SHALL BE LAID OUT AND BE LOGICALLY ARRANGED FOR SIMPLICITY OF ACCESSIBILITY AND ELECTRICAL EFFICIENCY
- ON ALL EQUIPMENT TO INDICATE FUNCTION, VOLTAGE AND POWER OF DEVICES.
- THIS SPECIFICATION IS NOT INTENDED TO RESTATE THE APPLICABLE CODES. THE CONTRACTOR WILL BE RESPONSIBLE FOR PROVIDING ALL GROUNDING, ETC. AND FOLLOWING ALL WIRING METHODS.
- THE CONTRACTOR SHALL EXAMINE THE CONDITIONS OF THE SITE AND SHALL BE RESPONSIBLE FOR ALL EQUIPMENT, MATERIAL, AND LABOUR NECESSARY FOR THE WORK REQUIRED FOR THIS PROJECT.
- PRIOR TO SCHEDULING FINAL INSPECTION, THE CONTRACTOR SHALL ENSURE THAT ALL WORK IS COMPLETED AND N PARTICULAR, THAT OPERATION AND MAINTENANCE MANUALS ARE COMPLETED, ALL NAMEPLATES INSTALLED, VERIFICATION TESTS HAVE BEEN DONE AND CERTIFICATES HAVE BEEN RECEIVED THAT INDICATE WORK INSTALLED CONFORMS TO ALL REQUIREMENTS.

- ON THE EXISTING POLES. EXISTING WIRING SHALL BE USED TO CONNECT THE NEW LIGHTS. THE UNDERGROUND VAULT TO THE L06 TO L20 LIGHT BOLLARDS AS SHOWN ON THE DRAWING. OF
- SINGLE PHASE BOLLARD LIGHTS MOUNTED TO THEM.


## DELIVERABLES

THE CONTRACTOR SHALL MAINTAIN ONE SET OF PLANS AT THE JOB SITE WHICH CLEARLY NOTE ALL CHANGES OR DEVIATIONS FROM THE CONTRACT DOCUMENT AS THE JOB PROGRESSES. THE CONTRACTOR SHALL SUBMIT THREE SETS OF AS-BUILT DRAWINGS TO THE CONTRACT ADMINISTRATOR ON COMPLETION OF THE JOB.

## AIMING AND ACCEPTANCE TESTING

THE CONTRACTOR SHALL MEET THE CONTRACT ADMINISTRATOR ON SITE TO VERIFY/AIM LUMINAIRES AND TO MEASURE LIGHTING LEVELS ON COMPLETION OF THE WORK. NOTE THAT SITE VISIT WILL BE REQUIRED AFTER DARK. OTHER

EXACT LOCATION OF BOLLARD LIGHTS TO BE APPROVED BY THE CONTRACT ADMINISTRATOR, PRIOR TO INSTALLATION. WIRING TO BE RWU90, MINIMUM #8 AWG. DIRECTIONALLY BORED CABLE WIRING SHALL BE RUN IN POLYETHELENE CONDUIT SUITABLE TO COUPLE TO THE CONDUIT CAST INTO CONCRETE FOOTINGS. ALL CONNECTIONS TO BE WATERTIGHT COMPLETE WITH FS BOXES. NO UNDERGROUND SPLICES WILL BE PERMITTED. THE CONTRACTOR TO COORDINATE ALL LOCKS WITH THE PARKS & OPEN SPACE DIVISION ELECTRICIAN. DIMENSIONS SHOWN ON DRAWINGS ARE IN METERS UNLESS OTHERWISE SPECIFIED
